ZONING REPORT:

(Zoning Administrator Daus reported on the following items)

- Reminder that the December Planning Commission Meeting will be a week earlier (December 18th) instead of the normal scheduled date which is on Christmas Day.
- Received application from TLS to amend their Site Plan to now show the destruction of the house that is on the site and add an office to the structure that is already on the plans. This will come to the Planning Commission next month.

HOWELL TOWNSHIP PARK'S REPORT:

(Commissioner Haglund reported on the following items)

• The Parks Site Plan is out to the public for review until December 1st. There has only been 1 comment from the public: to have a Splash Pad to bring in revenue to the Township. The Site Plan will go to the Board for approval.

UNFINISHED BUSINESS:

A. PUBLIC HEARING, LACASA, PARCEL #4706-27-100-003, FILE #2018-26

- Township Planner Montagno introduced the application for rezoning of the roughly 20 acre property located at 1920 Tooley Road. The applicant is requesting to rezone from "SFR" Single Family Residential to "RSC" Regional Service Commercial. The current development is a single family home. The proposed development is for LACASA's new facility. The surrounding area is primarily rural area properties with the EMS building located across the street next to the airport. Planner Montagno indicates the proposed use for the property is appropriate within the future use of the Township Master Plan. LACASA activities will include office use, counseling use and shelter services.
- MOTION by Freude, seconded by Henry, "TO OPEN THE PUBLIC HEARING FOR LACASA." Discussion followed. Motion carried.
- Questions and concerns were taken from the Commissioners.
- Bobette Schrandt from LACASA explained what LACASA does. Administrative as well as counseling and emergency shelter for domestic and sexual assault victims for Livingston County and surrounding areas. They collaborate with the court and law systems. There also is area for medical set up for exams from assaults. There is a Children's Center which services all of Livingston County. LACASA is non-profit. LACASA likes this location because it is right across from the EMS and use their services frequently and is not too far from the courts and sheriff departments.
- More guestions and concerns were taken from the Commissioners.
- There were no comments from the public.
- MOTION by Henry, seconded by Manwiller, "TO CLOSE THE PUBLIC HEARING FOR LACASA." Motion carried.
- Comments and further discussion was taken from the Commissioners and the Township Planner.
- MOTION Counts, seconded by Henry, "TO RECOMMEND APPROVAL OF LACASA, PARCEL #4706-27-100-003, FILE #2018-26 TO REZONE PARCEL FROM "SFR" TO "RSC" TO THE TOWNSHIP BOARD, SIGHTING THE PLANNER'S REPORT DATED NOVEMBER 20, 2018." Discussion followed. A roll-call vote was taken: Matthew Counts yes, Haglund yes, Henry yes, Williams no, Manwiller yes, Sloan yes, Freude yes. Motion carried 6 to 1.

B. AMERICAN LEGION, PARCEL #4706-28-100-010, FILE #PC 2018-17

- Chairman Sloan stated that the sign application for American Legion was tabled in March due to a moratorium placed on all sign application. The moratorium has now been removed.
- Township attorney Fahey stated there is a change in plan due to the fact that the applicant has filed a law suit
 against the Township in Federal Court. He recommends that the Planning Commission go into Closed Session
 to discuss strategic issues in respect about the law suit with the attorney.
- Tara Pearson from Parker and Parker questioned about the item being placed on the agenda when the American Legion did not request to be on the agenda. Ms. Pearson stated she is the attorney only as local counsel and not the attorney in the federal law suit.
- Township attorney Fahey stated this was added to the agenda only for the purpose to discuss, in a closed session, the law suit with the Commissioners. There will not be any action taken tonight. It will remain tabled.
- MOTION by Henry, seconded by Williams, "TO ENTER INTO CLOSED SESSION AT 7:30 P.M. TO DISCUSS STRATEGY IN CONNECTION WITH CROSSROADS LITIGATION." Discussion followed. A roll-call vote was taken: Freude yes, Williams yes, Manwiller yes, Henry yes, Counts yes, Haglund yes, Sloan yes. Motion carried 7 to 0.
